## DSC President Comments June 2023

## Welcome to summer!

May is the start of our new year. The board has been hard at work planning our calendar. Our Western ski season includes trips to Snowmass and the CMSC Chicago Week trip to the Big 3 (Banff Sunshine, Lake Louise and Mt. Nor quay). In the Midwest, we are planning our Chestnut Mountain weekend, a bus trip to Afton Alps with the Nomads and several drive-up trips including a weekend at Nub's Nob, Boyne Highlands and Boyne Mountain (likely staying in Petosky) and a trip to Lützen Mountain in late March. We hope our extended ski schedule gives everyone opportunity to ski in 2024!

Thank you to Bill Stocky, Henry Bottando, Matt Pendowski and Joe Joyce for going to the Trip Seminar. Ed and Janice Shifley Gordon also were there working for the CMSC. Two of the most significant things we learned was, smaller clubs would be wise to team up with other clubs for trips to get economy of scale. We have already been sharing trips with the Nomads but may explore whether another small club would also join us to lower our overall cost of a trip. From the Sanctuary Club, we learned they always get two bids and compare the lodging options which often gets them a lower price. They are also flexible on their week and day they fly in/out if the air would be reduced.

Winter Ski and Sport shared they have a lot of problems with untrained trip leaders which requires them to have more staffing. At the trip seminar, they announced they will have a trip leader training program recommended for all trip leaders, whether using them as this year's tour operator or not. Any club who uses Winter, Ski and Sport as their trip operator and the trip leaders are not taking the training, will pay a higher price. We will be encouraging all our trip leaders to take this training as this is a rare opportunity.

Hope to see many of you over the summer – come join us at one of our monthly Duneland Dine arounds, weekly bike rides, the June 16<sup>th</sup> Gary RailCats game, July 7-9 Pine River canoe and camping weekend, August 19 pool party and/or the Valpo Night Ride- all of which promise to be fun. See you there!



#### **RESPONSIBLE BEHAVIOUR (Please read and sign below)**

Members should be keenly aware that their actions reflect directly on the ability of the DSC to provide activities in the future. Not only do their actions influence the cooperation of the organizations servicing the activities, but they also influence other individual's willingness to participate in future activities. While the DSC does not desire to dictate the behavior of individuals, past incidents indicate that the club must provide a system through which offensive actions can be defined and dealt with while still protecting the legitimate interests of all concerned.

The following list of illegal, socially offensive, or morally degrading actions shall be just cause for dismissing a member from the club or from future activities for a stated period of time:

- 1. Any felony.
- 2. Any action which would be the basis for a service organization to the DSC to withdraw services.
- 3. Any wanton or wasteful destruction of property.
- 4. The continuation of any grossly socially unacceptable activity as judged by any of the people participating in the activity.

5. The threat of bodily damage to anyone or the use of force. These actions should be judged by the board. Any complaints must be preceded by a written statement from a member. The statement should contain the names of the specific people involved and the circumstances. The offending party will be notified and given adequate time (30 days) to reply to the charge.
